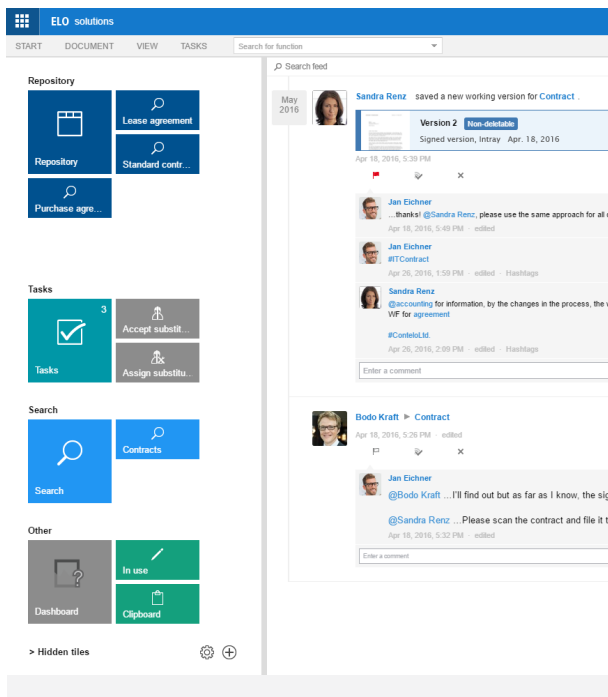

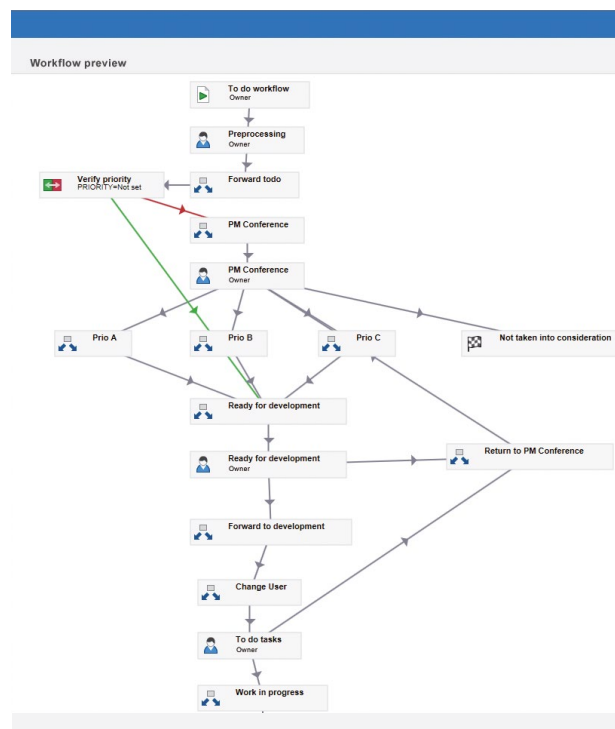

Accelerate business processes

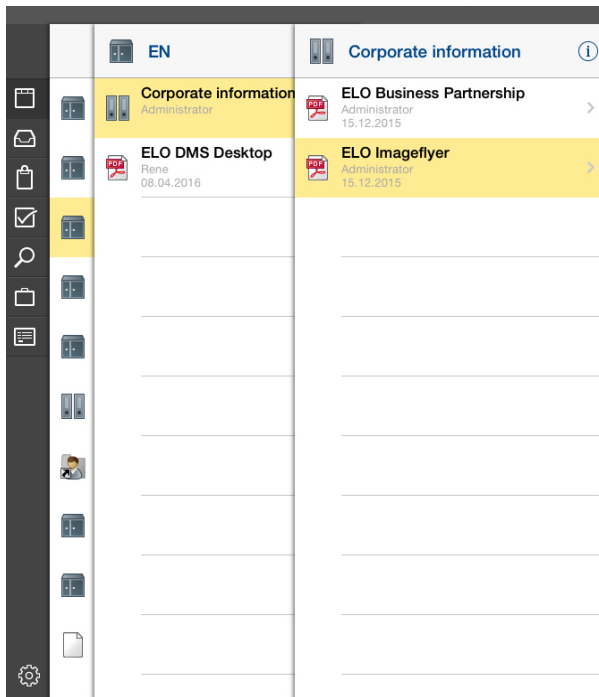

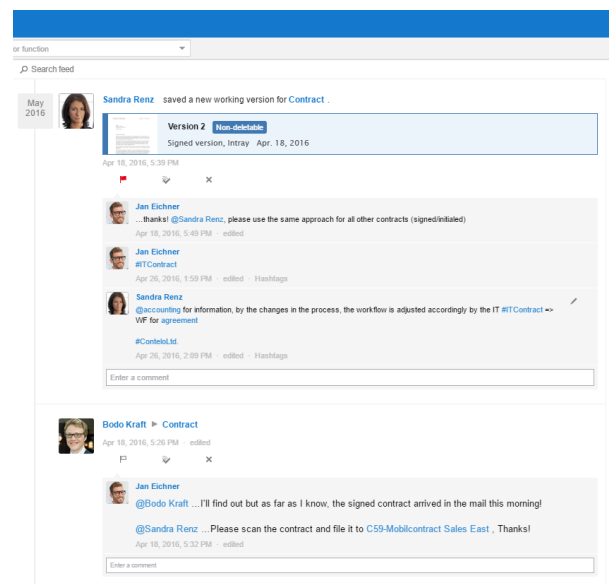
